## A note about language...

"She" as the victim and "he" as the harm doer (perpetrator)

 Research shows us that about 90% of sexual assault victims are women and the majority of perpetrators are men.

- Non gendered pronouns (they/them)
  - Victims and harm doers can be of a non-binary gender

## **3 Core Beliefs**

- Individual justice and collective liberation are equally important, mutually supportive, and fundamentally intertwined
- The conditions that allow violence to occur must be transformed in order to achieve justice in individual instances of violence
- State and systemic responses to violence not only fail to advance individual and collective justice but also condone and perpetuate cycles of violence

### What is transformative Justice?

"Transformative justice examines behaviors and systems as opposed to simply the individual actor. Further, a transformative justice process would work to address power and privilege both in the community and in larger systems in relation to the specific harm and with broader community prevention in mind." -WCSAP

### **Goals of Transformative Justice**

- Survivor safety, healing and, agency (reinforce autonomy and self sufficiency)
- Accountability and transformation of abusers (Duluth Abuse Intervention Project)
- Community accountability (*The Natural Helpers Program*)
- Transformation of the social conditions that create and perpetuate violence (systems of oppression, exploitation, domination, state violence, etc.)

#### Transformative Justice Aligns with Trauma Informed Survivor Centered Care

#### <u>Trauma Informed</u> <u>Survivor Centered Care</u>

- Prioritizes the rights, needs, and wishes of the survivor.
- Realizes the widespread impact of trauma and understands potential paths for recovery.
- Seeks to actively resist retraumatization.

#### **Transformative Justice**

- Supports survivors by reinforcing their autonomy and selfsufficiency.
- Survivors are provided options to decide what will help them in their safety, transition and healing.

### **Steps Towards Transformative Justice** Agencies should ask themselves...

- How do the Transformative Justice principles align with or challenge the mission and politics of the agency?
- What kind of criteria exists for deciding when to and when not to engage the State? What protocol and policies are in place to respond to violence outside of State intervention?
- What preparation might be necessary to develop and support community-based responses to and prevention of violence?

### **Steps Towards Transformative Justice**

- Move away from incarceration as a solution
- Prevention
- Unpacking our own patriarchal actions and beliefs
- Empower people rather than institutions to make decisions
